The registered driver undertakes to abide by the rules of the event and premises, both in terms of content and form, and shall at all times follow the instructions given by the security and organisation staff during the event.

Drivers are required to take out personal insurance to cover the risks involved in this activity. Current federation licences will be accepted and shall be submitted together with this disclaimer form. For motorcycling, only current and officially approved regional or national licences shall be accepted. For official motor racing competitions, federation licences will only be accepted when this is provided for in the race insurance. AECV's Forfait annual insurance will be accepted provided the relevant certificate is submitted as proof of having taken out this insurance. Other types of insurance policies may be accepted provided a current insurance policy or certificate is submitted, specifying that the insurance in question covers the risks involved in this activity and that the minimum policy coverage is at least equivalent to that required by MOTORLAND.

Users who do not have a federation licence or any other type of insurance to cover the risks associated with the activity are obliged to take out accident insurance. MOTORLAND can assist users in taking out this insurance, the coverage of which is specified in the certificate available to users on request. Users taking out this insurance are aware of and accept the terms and conditions of the accident insurance policy procured by MOTORLAND.

The undersigned, his heirs and other legal representatives shall not hold the organisers liable for any civil or criminal liability arising out of his participation in the event, or for risks and damages of any kind that are not covered by the insurance policies that were taken out, and shall not bring any claims for losses or damages against the organiser, the racing circuit or any other persons involved in the organisation of the event.

In the event of an accident, the undersigned undertakes to report the accident and the damages or injuries caused within at least 24 hours of the accident occurring. MOTORLAND shall accept no responsibility in this respect unless the accident is reported within the aforementioned deadline.

The undersigned undertakes to prevent third parties from using the vehicle unless they have the prior express consent of the organiser.

The organiser hereby informs the driver that it is his sole responsibility to use the officially approved personal safety elements, in perfect condition, required by the relevant sports federations for participation in official races; in particular, helmets, gloves, race suits, boots, head and neck support devices and/or any other items.

The driver warrants that he is aware of the MINIMUM MANDATORY SAFETY RULES, which have been expressly communicated to him, such as not getting out of the vehicle or walking on the circuit for any reason; in the case of a breakdown and/or accident, he should get the vehicle off the track (ideally by himself, and without getting out of the vehicle) and make it available to the organiser's staff; the driver and/or any persons accompanying him should never cross the pitlane line on foot; persons not authorised by the organiser, persons under the age of 16 years (other than drivers) or pets should under no circumstances enter the pitlane; never, under any circumstances, drive in the opposite direction; when a yellow flag is waved, reduce the speed as there may be people and/or obstacles on the track and take extra care when leaving the track using the exits designed for this purpose; in such cases, it is prohibited to overtake other vehicles; never use spark-producing equipment (such as soldering tools) or any other flammable devices on the premises; it is expressly prohibited to drive unauthorised or uninsured vehicles in the paddock, or to cycle bicycles, scooters (whether motorised or not); smoking in or around the boxes, pitlane or race track areas is expressly prohibited.

For the good of all those persons involved in the event in general and the driver in particular, the organiser of the event warns the latter against the consumption, even several hours prior to the event, of stimulants, medicinal products, beverages and/or any other substance(s) that might affect the behaviour of the driver (or, when applicable, his companion) or his ability to drive the vehicle. He shall refrain from driving the vehicle in the event that he has taken any of these substances. Driving a vehicle, whether in the aforementioned circumstances or in normal physical and mental conditions, is an activity that carries a risk and may therefore give rise to accidents through the fault of the driver or third parties, which may result in serious injuries and even death.

Accordingly, the undersigned is fully aware of the risks and possible consequences of his participation in the activity and accepts, of his own free will, full responsibility for these risks. Improper or reckless use of the vehicle, at the discretion of the organiser, shall be grounds for expulsion from the event and the driver shall not be entitled to any refund of the registration fee whatsoever.

The purpose of this event is to improve driver safety by driving in a closed circuit in controlled safety conditions, without the adverse traffic conditions you would find on a road. The organiser strictly prohibits races and competitions within this event. Failure to comply with this rule shall be grounds for expulsion from the event.
